BOND FOR MARRIAGE LICENSE.

Know all Men by these Presents:
That we, Mr. McKelvey as Principal,

and Miss Belva S. Whelchel as Security,

are held and firmly bound unto the State of Arkansas, for the use and benefit of the Common School Fund of Greene County, in the penal sum of One Hundred Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, jointly by these presents.

Signed this 29 day of Nov 1916.

THE CONDITION of the above obligation is such that, whereas, the above bounden Mr. McKelvey has this day applied to the Clerk of the County Court of Greene County, for a license authorizing the solemnization of the Rite of Matrimony between the said Mr. McKelvey and Miss Belva S. Whelchel

Now, if the said parties applying for said license have a lawful right to the same, and if they shall duly carry into effect and comply with the provisions thereof, and shall within sixty days from the date hereon, return this said license to the office of the Clerk of the County Court of said County, duly executed and officially signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void, but otherwise to remain in full force and virtue.
