for the use and benefit of the Common School Fund of Greene County, in the penal sum of One Hundred
Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, jointly by these presents.

Signed this 6 day of Decr 1902

The Condition of the above obligation is such that, whereas, the above bondmen,
this day applied to the Clerk of the County Court of Greene County for a license authorizing the solemnization of the Rite of Matrimony between
the said John McKelvey and James A. Jeffers
Now, if the said parties applying for said license, have a lawful right to the same, and if they shall duly marry into office and comply with the provisions
thereof, and within sixty days from the date hereof, appear in the office of the Clerk of the County Court of said County, duly sworn and duly
signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void, but otherwise it remains in full force and effect.
