BOND FOR MARRIAGE LICENSE

STATE OF ARKANSAS,
County of Greene.

KNOW ALL MEN BY THESE PRESENTS, That we, Garth A. McKelvey as principal, and J. H. Taylor as security, are held and firmly bound unto the State of Arkansas, for the use and benefit of the Common School Fund of Greene County, in the penal sum of ONE HUNDRED DOLLARS, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, jointly by these presents.

Signed this 29th day of Nov 1913.

That the execution of the above obligation is such, that whereas, the above bounden Garth A. McKelvey has this day applied to the Clerk of the County Court of Greene County for a License authorizing the solemnization of the Rite of Matrimony between the said Garth A. McKelvey and Miss Mildred Stevenson.

Now, if the said parties applying for said License have a lawful right to the same, and if they shall faithfully carry into effect and comply with the provisions thereof, and shall, within sixty days from the date hereof, return said License to the office of the Clerk of the County Court of said County, duly executed and officially signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void, but otherwise to remain in full force and virtue.
