McKelvey* and *Ora Bragg*, as Sureties, are held and firmly bound unto the State of Arkansas, for the use and benefit of the Common School Fund of *Greene* County, in the penal sum of One Hundred Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, jointly by these presents.

Signed this *3* day of *Aug* 190*1*.

Witness the Hand of the above obligors, the above binders, this day applied to the Clerk of the County Court of Greene County for a license authorizing the solemnization of the Rite of Matrimony between the said *D. P. McKelvey* and *Ora Bragg*.

Now, if the said parties applying for said license, have a lawful right to the same, and if they shall satisfy every law and ordinance, jointly with the provisions thereof, and shall within sixty days from the date hereof, return the said license to the office of the Clerk of the County Court of said County, duly executed and officially signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void, and otherwise to remain in full force and effect.
