Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, jointly by these presents.

Signed this 16 day of Nov 1901

The condition of the above obligation is such that, whereas, the above bond was
this day applied to the Clerk of the County Court of Greene County for a license authorizing the solemnization of the Rite of Matrimony between
the said John C. Brewer and Chara McKelvey
Witness: If the said parties applying for said license, have a lawful right to the same, and if they shall duly carry into effect and comply with the provisions
thereof, and shall within sixty days from the date hereof, return to the office of the Clerk of the County Court of said County, said license and actually
signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void; but otherwise to remain in full force and effect. Witness
