Know All Men By These Presents: That we George Spillman as Principal,  
and J. W. Cothren as Security, are held and firmly bound unto the State of  
Arkansas, for the use and benefit of the Common School Fund of Greene County, in the penal sum of One Hundred  
Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, firmly by these presents.

Signed this 19 day of May 1905

THE CONDITION of the above obligation is such that, whereas, the above bounden George Spillman  
has this day applied to the Clerk of the County Court, of Greene County, for a license authorizing the solemnization of the Rite of Matrimony  
between the said George Spillman and Miss Charlie Lou Roe

Now, if the said parties applying for said license, have a lawful right to the same, and if they shall safely carry into effect and comply with the  
provisions thereof, and shall within sixty days from the date hereof, return the said license to the office of the Clerk of the County Court of said County,  
duly executed and officially signed by some one authorized by law to solemnize the Rite of Matrimony, then this obligation shall be void; but otherwise to  
remain in full force and virtue. Witness our signatures the day above written.
