Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, our executors and administrators, firmly by these presents.

The Condition of the above obligation is such that whereas, the above bounden M. J. Spillman
has this day applied to the Clerk of the County Court of Greene County, for a license authorizing the solemnization of the Rite of Matri-
mony between the said M. J. Spillman 28 and Mary Willie Rose 39

Now, if the said parties applying for said license, have a lawful right to the same, and if they shall safely carry into effect and comply with the provisions thereof, and shall within sixty days
from the date hereof, return the said license to the office of the Clerk of the County Court of said County, duly executed and officially signed by some one authorized by law to solemnize the Rite of
