The condition of the above obligation is such that when as the above bound J. H. Swindle has this day prayed & obtained license to marry Isabela Bost now if the said Isabela Bost be an actual resident of this county and there shall appear no lawful cause why the said J. H. Swindle and Isabela Bost should not be joined to gether in holy matrimony as husband and wife then this obligation to be void otherwise to remain in full force and effect J. H. Swindle
